## **CASA Program Overview**

- Unpaid, part-time Special Govt Employees (SGEs) under 18 USC 202
- "Experts and Consultants" under 5 USC 3109
- Afforded a 3-star protocol status
- Two-year term; may be renewed up to 5 terms (10 years)
- At least one CASA per state, DC and the 5 U.S. Territories
- Receive ethics training and daily Army briefings
- Governed by Army Reg 1-15 "Civilian Aides to the Secretary of the Army" (updated 1 March 2017)
- 130 days per year, 60 days for Defense Contractors



### **CASA Qualifications**

#### Army Regulation 1-15, a candidate must meet the following criteria:

- Be a United States citizen of outstanding character, integrity, and patriotism.
- Have a deep interest in military affairs.
- Be a leader in community affairs.
- Be in a position to disseminate information about the Army to a broad cross section of the public and to prominent citizens in their area.
- Be able to interpret and affect public attitude toward the Army.
- Not be an employee of the Federal Government as defined in 5 USC 2105.
- Not be a paid employee of any political party.



#### **CASA Selection Process**

- Upon vacancy, "Request for Nomination" letters sent
- CASA office compiles nominations and prepares slates of candidates
- SecArmy selects CASA or requests new nominees
- Selected nominee is notified and requested to complete OGE 450 to clear Ethics review. If OGC clears nominee of any conflict, the nominee is appointed and others are notified
- Investiture Ceremony and new CASA Orientation held (typically at the Pentagon)



#### **CASAs What We Do**

- Serve as a vital link between local and state communities and the Army:
  - Army senior mission commanders and installation commander
  - Recruiting/ROTC, Corps of Engineers
  - Guard and Reserve
  - Business and Civic leaders
  - Elected officials
  - Academia
  - Advise the Secretary of the Army on issues of local concern
  - Represent the Secretary of the Army at ceremonies
  - Submit reports on all activities



## **CASA Program Statistics**

- 125 CASA positions, 117 CASA positions filled
- 8 pending vacancies Alaska (South), Florida (South), Florida (North), Hawaii (Island of Hawaii), Louisiana (North), Maryland, Tennessee (East), and Texas (East)

#### **Active CASAs:**

- 80% were appointed in last 5 years
- Average age is 62
- 83% Male; 17% Female
- Estimated to be 75% White, 25% African American; Hispanic, Pacific Islander; Asian; Other
- 60% have known former Military Service; of those, 13% Flag Officers
- West Point Graduates: 23%



### **CASA COVID Response**

CASAs continue to be engaged during the COVID-19 pandemic:

- Increased social media outreach
- Assisting with community relief efforts
- Conducting virtual commissioning and promotion ceremonies
- Helping recruiters
- Connecting potential businesses to Army/FEMA




# History

#### The Congress shall have power...

- •To provide for calling forth the militia to execute the laws of the union, suppress insurrections and repel invasions;
- •To provide for organizing, arming, and disciplining, the militia, and for governing such part of them as may be employed in the service of the United States, reserving to the states respectively, the appointment of the officers, and the authority of training the militia according to the discipline prescribed by Congress;
- -- U.S. Constitution, Article I, Section 8
