

A Witness to History; My Navy Journey



Craig Quigley has spent his entire adult life supporting the nation and communities. A career naval officer, Mr. Quigley served 27 years on active duty, achieving the rank of rear admiral and serving as Deputy Assistant Secretary of Defense (Public Affairs) at the Pentagon.

Upon retiring from the Navy, Mr. Quigley accepted a position as Vice President of Communications & Public Affairs for Lockheed Martin Maritime Systems & Sensors, leading a 30-person communications team across eight states for a \$3.5B operating company. Following Lockheed Martin, Mr. Quigley returned to Federal government service as the Director of Communications for U.S. Joint Forces Command in Hampton Roads, VA during a time of great transition in that organization. Mr. Quigley then served for nearly 12 years as the Executive Director of the Hampton Roads Military and Federal Facilities Alliance, a public-private partnership dedicated to attracting, retaining, and growing Federal facilities to southeast Virginia.

Mr. Quigley is a 1975 distinguished graduate of the U.S. Naval Academy at Annapolis, MD and has served as president of his class. A native of Winthrop, IA, he is an active public speaker and believes in the value of mentoring juniors and developing teamwork to accomplish difficult objectives. He has been listed in "Who's Who in American High Schools" and "Who's Who in American Colleges and Universities," and was selected as an "Outstanding Young

LEGISLATION AFFECTING CAREGIVERS AND SURVIVING SPOUSES

CARING FOR SURVIVORS ACT OF 2025

Summary: H.R.2055 — 119th Congress (2025-2027) Introduced in House (03/11/2025)

It would increase Dependency and Indemnity Compensation (DIC) from the current 43% compensation to 55% for those with 100% disability. Also, it would reduce the number of years of disability to qualify from 10 to 5 years. As of December 2025, the bill has 105 co-sponsors.

VETERAN CAREGIVER REEDUCATION, REEMPLOYMENT, AND RETIREMENT ACT.

Summary: H.R.2148 - 119th Congress (2025-2027)

This legislation acknowledges caregivers' invaluable contributions by offering education, employment, and retirement opportunities, and improves caregiving support for veterans' families through expansion of home health and long-term care services to meet current and future needs of veterans, their caregivers, and families. Latest action: June 12, 2025. 8 co-sponsors (2 Rep, 6 Dem).

**ASK YOUR LAWMAKERS to Support the
Improve and Enhance the Work Opportunity
Tax Credit Act. Military spouses face a 21%**

unemployment rate, five times the national average, due to frequent moves and challenges tied to military life. Congress must incentivize employers to hire military spouses by adding them as a target group under the Work Opportunity Tax Credit (WOTC) program.

OUTREACH -- WHAT'S NEW?

Luke MOAA Casualty Assistance booklet and Caregiving booklet presentation was made to the AZCOC. During the presentation, the state chapter presidents requested that the material be made available to all SS Liaisons throughout the State of Arizona. This was completed this past month.

The booklets contain information for all uniformed services' families including phone numbers to call for grief assistance, burial assistance, what actions must be taken to initiate Survivor Benefit program and how to handle a veteran's retirement income, and what actions must be taken to initiate Survivor Benefit program. The Caregiving information has the free services that are available to veterans and their families for those who act as caregivers to their veteran spouse.



At the 2 December luncheon, we shared a Thank You letter from The Veterans Last Patrol to our members for the personalized cards we sent to them. During our meeting, we were able to complete an additional 30 more Thank You for Your Service cards for new veterans on hospice with our messages.

The Veterans Last Patrol Program supports veterans in hospice who have no family to be with them, and who are now awaiting deployment to a higher authority. We have now reached out to 80 veterans on hospice sharing our Thank Yous and letting them know they are not forgotten.

ARIZONA COALITION FOR MILITARY FAMILIES

Your Luke Chapter SS Liaison was contacted by Ms. Joy Sprink, Care Navigator for the Arizona Coalition for Military Families, to help with 2 Navy enlisted Surviving Spouses. After discussion and review of each case, it was found that both surviving spouses' husbands met the criteria for the Blue Water Act and additional PACT Act. The Acts, with the criteria met, were sent to Ms. Sprink along with Veterans Service Organization information.

In a follow-up email, Ms. Sprink contacted the Luke Liaison letting her know that the surviving spouses were found to meet the criteria and were helped. She expressed her thanks.

Board Briefs

Luke Chapter (LC)-January 15, 2026 Board Meeting

- President Gene Wikle gave his warm thanks to the Board and members of Luke Chapter for the opportunity to serve as President over the past three and one-half years. His recently enhanced job responsibilities in Arizona crisis and emergency management compelled him to step down from office. Gene will continue to be a member of Luke Chapter and will support our mission at a reduced level to the extent possible. The directors voice their strong gratitude and appreciation for the great work Gene has done over so many years.
- Treasurer Jack Coate reported that the current asset balance of Luke Chapter (LC) on 31 December 2025 is \$40,878 of which \$24,877 is unrestricted equity.
- Assets of Community Fund on 31 December 2025 are about \$93,178, with unrestricted equity of \$40,106. Annual fund-raising activities will begin this spring in 2026 under direction of the Community Fund Board of Directors.
- Lt Gen Regni submitted his report on legislative liaison activities at MOAA, AZCOC and for Luke Chapter. The Arizona Legislature is currently in session and will consider potential bills of consequence for the military community, active and retired. Gen Regni will be meeting soon with Senator Mark Kelly to apprise him of MOAA Advocacy in Action and Arizona legislative priorities.
- RDML Craig Quigley, director of Communications, Programs and Venues, secured firm reservations for lunch and



dinner meetings at the Chianti Room, PebbleCreek, in Goodyear, for February through May 2026. The Board approved Craig's proposal to subsidize somewhat higher costs charged at the PebbleCreek venue, to encourage other officers residing in West Valley to attend and join our chapter. Our outside CPA concurred that a reasonable 'overspend' is legally permissible to encourage membership, program participation, secure an adequate meeting room, and further Luke Chapter's missions.

- Mike Kramer reported that the annual report to the Arizona Corporation Commission for the Community Fund will be due by mid-March.
- Mike will draft the annual Levels of Excellence nomination for Luke Chapter and submit it when due to MOAA later this month.
- David Ciesielski, Director of Scholarships, reported that the webpage was updated with current rules for the program, notices were sent to JROTC programs and existing scholarship winners to apply no later than 17 March for awards. David will ask for volunteers for the scholarship selection committee later this spring.
- The Veterans' Relief Grant program has granted about \$13,000 since October to six financially needy veterans and families for housing, utilities, and related expenses. Approximately \$12,500 remains available this year for grants to needy veterans.
- Luke Chapter currently has 142 Members on our roster, including 109 Regular Members and 33 Surviving Spouses, with 4 "Honorary" members. Ben Hayes continues to request payment of dues from some members for FY 2025-26, and will drop them from the membership rolls if dues are not paid. Linda Wolverton continues to recruit more SS mem-

bers. Ben will lead the chapter's recruitment efforts with an email and letter to about 1400 MOAA members in the West Valley who are not currently Arizona chapter members.

- Pam Wojtas reported that she has sent 'thank you' letters to many chapter members who collectively have donated more than \$26,000 to Luke Chapter Community Fund charities in calendar 2025.
- Linda Wolverton, SS Liaison, said her group is looking forward to visiting the museum at the former Williams AFB in Mesa. Some of our adventuresome ladies will take a walk through the fuselage of a restored B-24 bomber on display. Also, our chapter SS's have signed and mailed over 80 messages of appreciation to mostly elderly, former military members in poor health.
- The next Community Fund board meeting will be on 20 January, under direction of COB MGen Shanna Woyak. The focus of this meeting will be our annual fund-raising campaign for our charitable missions.

Helping Needy Vets

Luke Chapter Helps a Needy Widow Keep Her Home

"Thank you all for your help, I really appreciate the support!" So said 'Janet' with heartfelt warmth after learning that Luke Chapter will help pay her rent for two months grace.



Janet was interviewed and her grant application considered by Jerry Wojtas, Jack Coate, and Mike Byers, and Chair Beth

Johnson. She served her country in the US Army as a motor pool specialist. Janet was trained at Fort Leonard Wood and assigned to a post near Stuttgart, West Germany, before her honorable discharge in 1981.

Now 64 years of age, Janet was on the verge of being evicted from her rented apartment in Phoenix. Even worse, her car may soon be repossessed by the bank. She currently is rated 60% disabled by the Veterans' Administration, and the disability compensation presently is her only income. Until November, she worked for Amazon and supported herself but is now unemployed. Janet had shoulder surgery in December and expects more surgery to come.

Janet recently applied to Social Security Administration for disability compensation, but the decision will take a couple of months. She receives food from Meals on Wheels. In the meantime, Janet was only able to pay a part of her January rent. Luke Chapter kept a roof over her head and so far, her car is parked outside. The interview panel approved a grant of \$2,540 that gives her two months of grace on rent until the SSDI disability checks are expected to begin. We were not able to help with the car payment. When SSDI starts, she then expects to be able to meet her monthly living expenses.

Many disabled, older veterans we help need financial aid for a few months to get past a rough spot and then should be able to resume independent living. Luke Chapter never stops helping our fellow service members, veterans, and their families.

The Wall That Heals is coming to Surprise in 2026

Surprise Honored to be Selected as a Host Site for The Wall That Heals

The City of Surprise is honored to welcome ***The Wall That Heals***, a three-quarter scale replica of the Vietnam Veterans Memorial, along with its Mobile Education Center, to Mark Coronado Park from April 9-12. The exhibit will be open 24 hours a day until 2 pm on Sunday and is free for the public to experience.

The Wall That Heals honors the more than three million Americans who served in the Vietnam War and bears the names of the 58,281 men and women who gave their lives in service to our country.

"Hosting ***The Wall That Heals*** is deeply meaningful to our community," said City of Surprise Mayor Kevin Sartor. "It allows us to honor the bravery of those who never returned home, and to create a place of connection, remembrance, and healing for all who visit."

"The Vietnam Veterans Memorial Fund (VVMF) is pleased to bring ***The Wall That Heals*** to Surprise, Arizona to allow local veterans and their family members a chance to experience The Wall," said Jim Knotts, president and CEO of VVMF. "Hosting ***The Wall That Heals*** provides an opportunity to honor and remember all those who served and sacrificed in the Vietnam War and educate visitors on the continuing impact of the Vietnam War on America."

The Wall That Heals travels the country in a 53-foot trailer that transforms into a mobile Education Center, featuring exhibits that tell the

story of the Vietnam War, the creation of the Memorial, and how this era shaped the way our nation honors its veterans.

The three-quarter-scale Wall stretches 375 feet in length and stands 7.5 feet high at its tallest point. Visitors can walk along the rising panels toward the apex, mirroring the design of the Memorial in Washington, D.C., and may also make name rubbings of individual service members.

The mobile Education Center includes digital photo exhibits honoring service members from the local area whose names appear on The Wall, as well as those recognized through VVMF's In Memory program for veterans who returned home and later passed away. Additional displays share historical timelines, personal artifacts left at The Wall, educational videos, and stories that place the war and its legacy in a broader cultural context.

National support for the exhibit comes from USAA, serving as presenting sponsor for the twelfth year, and Wipfli, returning for its second year as a supporting sponsor. Through partnerships with the Truckload Carriers Association (TCA), the trucking industry, and Blue Beacon, the exhibit can travel to communities nationwide.

Since its debut in 1996, The Wall That Heals has visited more than 800 communities across the United States, as well as Ireland and Canada. Operated by the Vietnam Veterans Memorial Fund (VVMF), it is the only traveling exhibit connected to the Washington, D.C. memorial and features the largest mobile Wall replica in the country.
